SEATTLE CITY LIGHT CONTINUES INTO 2024 WITH INCREASED INCENTIVES UP TO 60% AND FUNDING OPPORTUNITIES THAT EXPAND BEYOND EQUIPMENT REPLACEMENTS AND UPGRADES

Now offering Energy Project Manager for commercial and industrial customers, which helps pay the costs associated with coordinating multiple energy efficiency projects. Also offering Project Development Incentive, which offers an additional incentive for projects completed before the end of June 2024 (for a \$0.025 kWh rate).

Commercial rebates and retrofit incentives for lighting, lighting controls, insulation, advanced rooftop controls, and package terminal heat pumps are still available and were recently increased by up to 60%.

Other commercial program updates include Go Electric incentive updates and Express Energy Solutions updates.

AMEREN MISSOURI ENERGY EFFICIENCY PROGRAM BEGAN JANUARY 1, 2024

Incentives are available for lighting, HVAC, motors, commercial cooking, electric water heating, compressed air, refrigeration and motor controls.

2024 UPDATES FOR BGE, PEPCO AND DELMARVA POWER REBATE PROGRAMS

BGE Smart Energy Savers is now accepting new 2024 applications for all programs. BGE is continuing the 2023 incentive rates for prescriptive and custom measures.

Delmarva Power and Pepco Energy Savings for Business are accepting new applications starting January 15, 2024. Incentive levels for 2024 will be announced soon.

Updates were made to the application portals for both the BGE Smart Energy Savers and the Delmarva Power and Pepco Energy Savings for Business rebate programs in December. A new user's guide will be released shortly.

SALT RIVER PROJECT BUSINESS SOLUTIONS NEARING THE END OF THE FISCAL YEAR: LIGHTING SPIFF UPDATES AND MORE

The SRP Business Solutions FY24 program year ends April 30, 2024. All projects completed before that deadline are eligible for SRP Business Solutions rebates and contractor incentives (spiffs).

Pre-approval is required for retrofit lighting projects only.

The available rebate funding for standard incentives is 40%. The available rebate funding for custom incentives is 30%.

SRP is now offering a tiered contractor incentive for retrofit lighting projects completed through the Standard Business Program in FY24. Those who are approved as Energy Efficiency Alliance (EEA) members and submit eligible lighting projects can receive a contractor incentive for their customer's projects.

The spiff is 5%, 8%, or 10% of the final lighting project's rebate. The spiff is paid separately from the rebate and does not detract from the rebate funds for the customer.
