FIRST ENERGY OHIO LIGHTING INCENTIVES PROGRAM UPDATES FOR LIGHTING CONTROLS

Boost your energy savings and drive greater incentives with lighting controls. Effective December 1st, receive additional incentives* for any new application submitted when your project includes eligible lighting controls. Incentive level will vary based on level of control.

Tier 1 – Zoned control earns an additional \$0.05 per kWh saved

Tier 2 – Fixture level control earns an additional \$0.08 per kWh saved

Tier 3 – Network lighting controls earns an additional \$0.10 per kWh saved

Additional incentives will be available until April 30th, but don't wait, as additional funds are limited! Contact your account manager today for more information.



ENDING PROGRAMS

Efficiency Vermont's SMARTLIGHT Rebate Program ends this year, with the last day to make rebate eligible sales being December 31, 2023.

Efficiency Vermont will continue to offer custom rebates through their Custom Lighting Program.

Energy Trust of Oregon (ETO) will end incentives for replacing screw-in CFLs will continue to be available on July 1, 2024.

ETO Incentives for replacing inear fluorescent lighting and pin-style CFLs will be available until the sunset date of July 1, 2025.

FOCUS ON ENERGY REBATE CHANGES FOR EQUIPMENT INSTALLED AFTER JANUARY 1, 2024

Heat pump installations replacing an existing heat pump are only eligible for a \$400 rebate. Insulation and air-sealing rebates for both residential and multi-family properties remain unchanged. Solar rebates for both residential and commercial properties remain unchanged. Additional technologies and incentives added for multifamily properties and are listed below:

Thermostatic radiator valves - \$20 per installed valve.

Multifamily building tune-up – low to no-cost changes to multifamily properties are eligible for an operations maintenance incentive of \$150 to \$750.

Steam trap survey and repair incentives increased.

Custom incentives increased by approximately 300%.

SMART \$AVER PRESCRIPTIVE INCENTIVES FOR SELECT UPGRADES WILL BE DECREASING EFFECTIVE JANUARY 1, 2024

Incentives for the following upgrades will be reduced starting January 1: Connected smart thermostats (Carolinas & Indiana) currently \$93.50, soon \$60

Guest Room Energy Management, electric heating (Carolinas only) currently \$88, soon \$80

LED Highbay fixture replacing 2-lamp 8ft T12 fixture (Carolinas only) currently \$33, soon \$23

Roof insulation (Carolinas only) currently \$0.55/sq ft, soon \$0.28/sq ft.

Customers must have electric heating to qualify for roof insulation rebate.



COMED HAS A 48% AVERAGE INCREASE ON SELECT STANDARD INCENTIVES STARTING JANUARY 1, 2024

Includes popular refrigeration and compressed air equipment

Incentives for EC motors for walk-in coolers and freezers to increase by 50%

Incentives for high-efficiency air nozzles to increase by 150%
